



## TERMS & CONDITIONS

By registering for AFIC, you agree to be bound by the terms and conditions set out below.

### 1. Attendance

- Your attendance at AFIC is, at all times, at the sole discretion of Australian Festival Consulting Pty Ltd.
- Australian Festival Consulting Pty Ltd reserves the right to refuse entry to you to AFIC, or to request that you leave AFIC without notice for any reason whatsoever. If this occurs, then a refund of the registration fee will be facilitated in some circumstances (at Australian Festival Consulting Pty Ltd's sole discretion).
- You must at all times comply with:
  - these terms and conditions;
  - any terms and conditions imposed by Opal Cove Resort (**Venue**); and
  - any reasonable direction given to you by Australian Festival Consulting Pty Ltd staff, the Venue host, or any of their employees, agents or contractors; and
  - Australian Festival Consulting Pty Ltd reserves the right to immediately terminate the registration of any delegate that it reasonably believes is not complying, or has not complied, with the above terms.

### 2. Registration and Payment

- To register for AFIC, delegates must submit a registration form and follow any directions set out at <http://australianfestivalconference.com.au/register>
- Upon successful submission of your registration form, a confirmation of registration and tax invoice will be sent to your email address (as set out in your registration form). Please contact the organisers of AFIC on 0431 523 970, or email [info@australianfestivalconference.com.au](mailto:info@australianfestivalconference.com.au) if you do not receive a confirmation email.
- You must pay all registration fees, including any late fees, in full to Australian Festival Consulting Pty Ltd prior to the start of AFIC. If you do not, you will be refused entry into AFIC.
- Registrations for early bird tickets are priced at \$495 (+ GST) and close at 11:59PM 24 July 2019. Payments must be made prior to this date to be eligible for early bird ticket pricing.
- Registrations made after this date will be charged at the full rate of \$550 (+ GST)
- Registrations for full priced conference tickets close 12:00AM AEST Thursday 10 October, 2019



- Registrations for cocktail party tickets are charged at \$110 (+GST) and close 12:00AM AEST Thursday 16 October, 2019
- Credit card payments are made directly through Square to ensure your personal details are kept safe. None of your payment details are stored by Australian Festival Consulting Pty Ltd.

  - the substituted delegate is from the same organisation as you; and
